1. A copy of the relevant **PESTICIDE ORDER** detailing 'Directions for Use' which sets out in detail the directions for the safe use of '1080' baits and a copy is supplied herewith for:
2. I am aware and have read the contents of the relevant **PESTICIDE ORDER** listed above.
3. I am aware of the poisonous nature of '1080' and that I should remove any livestock from the area to be poisoned and keep them removed during the poisoning programme, except when using poisoned meat for wild dogs and foxes.
4. I am aware of my obligations to notify and inform **every person** whose boundaries are within one kilometre of the intended bait site (4km in the case of wild pigs), before intended use of the poison on the property described and that I have to place the required warning signs of the use of '1080' poison as directed in the relevant **PESTICIDE ORDER** listed above.
5. I undertake to destroy all prepared bait not laid, in compliance with the **PESTICIDE ORDER**.

I hereby declare that I have given no less than three (3) days notice either by **telephone/personal contact or writing** and such notice has been received by **every person** whose property boundaries are within:

1. In the case of poisoning rabbits, foxes and wild dogs one (1) kilometre of the intended bait sites.
2. In the case of poisoning feral pigs four (4) kilometres from the intended bait sites.
